CLIMATE RESILIENT WATER SECTOR IN GRENADA (G-CREWS) CHALLENGE FUND FOR TOURISM

Project Information

The Climate Resilient Water Sector in Grenada (G-CREWS) project is jointly financed by the Green Climate Fund (GCF), the German Federal Ministry for the Environment, Nature Conservation and Nuclear Safety (BMU) under its International Climate Initiative (IKI) and the Government of Grenada.

Over six years, the Government of Grenada, the Grenada Development Bank and the National Water and Sewerage Authority (NAWASA) in partnership with the German Development Corporation (GIZ) will implement the project's five components. The project responds to the challenges that climate change poses to Grenada's water sector by recognising that without decisive action to enhance the water sector's climate resilience, the people and ecosystems of Grenada will face increasingly serious climate-induced water scarcity over the next three decades.

What is the Challenge Fund?

The Challenge Fund for Tourism and Agriculture is part of Component Two (2) Commercial Water Users. The purpose of the Challenge Fund is to increase the resilience of these two commercial sectors which are both highly vulnerable to projected climate change impacts such as reduced precipitation and droughts.

The Fund promotes the adoption of water-efficient solutions in the agriculture and tourism sectors by using grants from the Green Climate Fund (GCF) to facilitate water auditing and solution design at no cost to the beneficiary and to incentivise significant private co-finance for the purchase of water-efficient equipment.



Challenge Fund for Tourism (CFT)

Hotels and guesthouses will be subsidized with equipment grants of up to 80% for the following:

- **Upgrading of bathrooms with more water-efficient showers, toilets and faucets (Up to US \$400 per bathroom and US \$20,000 per hotel)**
- **Installation or upgrade of rainwater harvesting systems or greywater recycling (up to US \$10,800 per small hotel or guesthouse, and US \$55,200 for large hotel)**

Implementation Arrangements:

1. **Audit conducted by the approved water expert and findings analysed in conjunction with water consumption history**
2. **Recommendations agreed between the expert and the property owner on the activities to be undertaken**
3. **Equipment procured and installed by the property owner**
4. **Installation inspected and certified by the water expert**
5. **Refund grant processed by the Grenada Development Bank**

Grant Eligibility Criteria

1. **Properties must be approved Grenada Tourism Authority (GTA) facilities**
2. **Audit of the property must be conducted by the approved expert**
3. **Property owners must be willing to implement the recommendations of the water audit**
4. **Purchase and installation of equipment of water efficiency solutions is to be carried out by the property owner prior to disbursement of the grant**
5. **Approval and certification of the installation by the water expert is a prerequisite for grant disbursement**
